

City Ordinance Chapter 69.08 No Parking Zones

In accordance with this chapter no one shall stop, stand, or park a vehicle in any of the following specifically designated no parking zones except when necessary to avoid conflict with other traffic or in compliance with the direction of a peace officer or traffic control signal.

Additional Parking Concerns

School Zones

No parking between 7:00am and 8:30am on the east side of S. 5th St. from 66 feet south of the School St. intersection to 63 feet north of the Highway 5 intersection. Also no parking between 7:00am and 4:00pm on the south side of School St. for 150 feet back east from S. 5th Street.

2 Hour Parking between 7:00am and 6:00pm Monday through Saturday

School St. on the south side from a point due south of the north intersection of Garfield and School St. east to the No Parking sign on School St.

School St. on the north and south sides between 1st St. and Garfield St

South Garfield St. on the east side from School St. to Highway 5

City Ordinance Chapter 51 Junk and Junk Vehicles

A Junk vehicle is defined as any vehicle legally placed in storage with the County Treasurer or unlicensed or licensed and having any of the following characteristic:

- Broken Glass
- Broken, Loose, or Missing Parts
- Habitat for Nuisance Animals or Insects
- Contains flammable fuel
- Is inoperable – no engine, missing 2 or more wheels, missing structural parts, that can't move under its own power for a period of thirty (30) days.
- Is defective or obsolete condition

Any junk vehicle will be considered a nuisance under section 51.04 of the City Ordinance.

Upon discovery of any junk vehicle located upon private property the City shall within five (5) days initiate abatement procedures as outlined in Chapter 50 of the City Ordinances.

City Ordinance Chapter 69.06
Parking Prohibited

- Cross Walks
- Center Parkway
- Within 20 feet of a mailbox
- Sidewalks
- In front of a driveway
- Within 10 feet of an intersection
- Within 5 feet of a fire hydrant
- Within 10 feet of a stop sign
- Within 50 feet of a railroad crossing
- Within 20 feet of the driveway of the fire station
- Alongside or opposite of street excavation
- No double parking
- Painted yellow curbs
- Fire lanes
- Alleys - must leave at least 10 feet for passing traffic
- Area between lot line and curb line
- Yards
- 48 hour limit on all street parking
- Handicap parking without permit - \$100 fine

If your vehicle is in violation, you will be subject to a \$15.00 fine and/or your vehicle may be towed at your expense.
Impounded Vehicles

Vehicles that have been impounded, weather do to a violation of City Ordinance or due to arrest will need to follow these steps to have your vehicle released.

- 1) The owner of the vehicle must appear unless a form has been signed and notarized by the owner saying it can be release to that person.
- 2) Releases will only be allowed Monday through Friday 8:00am to 4:30pm.
- 3) An administrative fee of \$25.00 will need to be paid at the City Hall office, per City Ordinance Chapter 80, prior to arrival at the Police Department.
- 4) All paperwork including a copy of the impound form, receipt of administrative fee paid in full, and any other supplemental paperwork such as a valid driver's license, updated insurance, updated registration, or proof of ownership, must be presented to the Police Department.
- 5) Once all the paperwork is verified an Officer or the Clerk will sign the release form and contact the appropriate towing company.

- 6) You will then need to make arrangements with the tow company to pick up your vehicle and pay the appropriate fees for towing and storage.

City Ordinance Chapter 69.12

Snow Ordinance

No person shall park, abandon, or leave unattended any vehicle on any public street, alley, or parking lot during any snow emergency parking ban unless the snow has been removed or plowed from the street, alley, or parking lot and the snow has ceased to fall and the flowing has stopped.

The City will enact the snow ordinance once two (2") or more inches of snow has fallen, the ordinance will be enacted and will remain in effect for twenty- four (24) hours after snow fall has ceased. Enacted means no person shall park, abandon or leave unattended any vehicle on any public street, alley or public parking lot during the snow ordinance.

If your vehicle is in violation of the snow emergency parking ban, you will be subject to a \$25.00 fine and/or your vehicle may be towed at your expense.
